GOVERNOR'S MANSION PROJECT

At our December 3 regular chapter meeting completed clocks #2 and #3 were put on display for the membership. Kathi Edwards brought the dial for the Whiting banjo which only required minor touchup. I had previously picked up the restored lower glass on the Whiting clock from Richard Mangum. Donna Kalinkiewicz brought the French Verdiere clock. The dial had been restored by Martha Smallwood. The dials for both clocks are beautiful, as is the Whiting glass restored by Rick. Our newest member, Pete Schreiner, volunteered to reblue the hands on the Whiting banjo. Donna & I gave a brief report on the restoration of both clocks.

On Tuesday, December 5, 2006 Bernie Tekippe, Brooks Coleman & I returned clocks #2 and #3 to the mansion.

Clock #2 the French gilt clock with dial signed VER-DIERE A PARIS was temporarily set up in Mrs. Perdue's office until the Holiday decorations are removed and the clock can then be returned to its original location in the Reception room.

Clock #3 the Banjo clock with dial signed S WHIT-ING, CONCORD, was hung in its permanent location in the Reception room. In turn the Waterbury banjo was removed from the same location, where it was temporarily located and returned to the upstairs President's bedroom.

While there Bernie made adjustments to the Black

French tole clock #7 located in Mrs. Perdue's office and the Colonial Tall case clock#5. The latter is running fine but we need to monitor the strike side and moon phase (both performed ok when tested).

Mrs. Perdue and Sharon Burrow again expressed their great appreciation to the chapter, for our work in restoring these clocks.

We also removed the last two French gilt mantel clocks

#'s 1 & 4 to Bernie's shop.



From in town: Take Ponce De Leon/78 past I-285 about 6 miles; exit on Hugh Howell Rd. At Chevron station, turn right on the Lilburn-Stone Mtn. Rd. After 0.2 mile, turn right on Old Stone Mtn. Rd. At the Rockbridge inter-Section, turn left and the Aquatic Center is 2 Blocks N. of intersection on left hand side. You'll see Gregg's Nursery across the street.

From the northwest: Take I-85 east at I-285 Exit to your right at Hwy. 140, Jimmy Carter Blvd. Go 1.3 miles to Rockbridge & turn left. 2 blocks before you get to Five Forks Trickum, the Aquatic Center will be on your right.
