Donald is an avid collector. He's shared some of his collection with us in the past, and today he brought 3 antique (or at least old style) cleaning machines. Donald's started his program with a small roast of our president and her husband, Carol and Bernie Tekippe and our favorite auctioneer, Brooks Coleman, playing a few hilarious videos.

Many members have asked about the recipes for cleaning solutions that Donald uses. Here are the recipes.

Cleaning Solution #1

- 1 gallon of clear ammonia
- 1 gallon hot tap water
- 1 drop dishwashing soap, like Ivory or Dawn (please note, using more dishwashing soap will make to many suds).

He uses the second solution for cleaning and polishing brass and metals.

Solution #2

1/2 C flour

1/2 C salt

1/2 C powdered laundry detergent

3/4 C white vinegar

1/4 C lemon juice

1/2 C very warm water

Mix all the dry ingredients, then stir in the liquid. Mix well. Keep in a labeled glass jar with a tight lid.

To use, shake a small amount onto a cloth and rub it into the surface of copper, brass, or bronze. Use a toothbrush for hard-to-reach places. Rinse with water and rub dry with a clean cloth.

TREASURER'S REPORT

In October, 2002, Mary Francillon suggested that I run for Treasurer and I thought that might not be too complicated, so I agreed. Never did I expect that the Job would last for Six Years! Mary had some 275 4x6 Cards for the Membership, from which she hand addressed the Newsletter. To make it easier to track the Dues Paid Members, she suggested that the Treasurer also maintain the Membership Data. On 12/10/2002, George Waterhouse and I met at Bernie's Classic Clocks, the checkbook was audited, and I acquired the Treasury. Each December, for the past six years now, George and I have conducted an Audit and reported to the Membership. By computerizing the Membership Database in Excel, I could quickly create Mail Labels for our Secretary Donna Kalinkiewicz to send the Newsletter, reduce the Member list down to 120 Dues Paid Members, and could create Meeting Name Tags, as well as periodic Member Rosters. Donna has encouraged members to receive the Newsletter electronically via Email thus reducing postage.

To provide better tracking of our Financial transactions, our Checking Account was set up in Quicken, picking up the Dec. 31, 2000 Balance, and loading all of 2001 & 2002 transactions from the checkbook. This made our Annual Audits, and monthly Bank recon- If you have a Seth Thomas crystal regulator Empire #0, ciliation quite simple. Eight Years of Financial Transactions will be transferred by Backup Disk to Donna's computer and to future Treasurers.

The Tools are in place to do a better job of tracking New Members from the NAWCC Membership Database, updated every two months, to assure the continued Growth of our Chapter.

I have appreciate the opportunity to serve our Chapter as your Treasurer.



At the Rockbridge inter-Section, turn left and the Aquatic Center is 2 Blocks N. of intersection on left hand side. You'll see Gregg's Nursery across the street.

From the northwest: Take I-85 east at I-285 Exit to your right at Hwy. 140, Jimmy Carter Blvd. Go 1.3 miles to Rockbridge & turn left. 2 blocks before you get to Five Forks Trickum, the Aquatic Center will be on your right.



From Cumming or Hall County: Exit off I-85 at Indian Trail, turn left. At Hwy 29, Indian Trail becomes Killian Hill Rd. At Five Forks-Trickum Rd. turn right and follow past the Depot to Rockbridge Rd and turn right. The Aquatic Center is 2 blocks N. on left.
