Extraordinary Reverse Glass Painting

If you've always been intrigued with the beauty of the reverse painted glass on American clocks of the early nine-

teenth century, then the processes and techniques will



week-long class at the NAWCC School of Horology in Columbia, PA in 2000. After nine years of many, many glass paintings, Rick proceeded to show the tools, supplies and techniques he has perfected in his personal application of his beautiful reverse glass painting. He supplemented his lecture and demonstrations with a well designed PowerPoint presentation.

Below is an overview of the detailed processes Rick presented during our meeting:

FIRST: Identify the border area of the glass that will be seen from the viewer's perspective along with marking a cross in the center for the bob opening and write the word "TOP" to

identify the top of the glass. Additional cross hatching lines help to line up future items in the picture. All of these lines are drawn on the nonpainted side of the glass.



SECOND: Stencil the borders - The glass is varnished and allowed to dry just until the varnish becomes tacky. Then the stencils are placed on the varnished glass and bronze powder is rubbed or brushed over the stencils. When you lift up the stencils the design is left on the glass. The powder Rick uses is called Green Gold. Although many bronze powders exist, he believes this particular color looks better on the older clocks. The stencils are made by drawing on paper; then the paper is

coated with shellac made by melting shellac flaks in denatured alcohol. The shellac coating will keep the template from adhering to the varnish. It's important to clean a stencil if it will be



used again to avoid smearing bronze powder accidently.

THIRD: Stencil the columns - The paper stencils work fine for flat surfaces, but for going around columns or non-flat surfaces, Rick suggested using Architect's Tracing Linen.



FOURTH: Finish borders by applying One Shot sign painters black paint over the bronzed stenciled items.

FIFTH: Gold Leafing (from Swift Company in

New York) – Apply a gel sizing to the glass to hold the gold leaf on the glass. The sizing is made by dissolving a clear gelatin medicine capsule in a cup of warm distilled water. The sheet of gold leaf is then laid down on the sizing. The design has also been carved into the gold leaf. The design is then

painted with One Shot black paint on the back of the glass. After the paint dries, the extra gold leaf is removed with a damp cloth. The design remains where the paint covered the gold



leaf. Gold leaf is an extremely thin film and this work is best done in a location free of drafts.

SIXTH: The Pictures - The items nearest the viewer (foreground items) are painted first. Buildings, trees and such are drawn on the glass with a technical pen with water based ink. If water based ink is used, the oil based paint will not smear the lines.

Restoration of existing painted glass is approached entirely differently. Typically, one has to remove parts of the painting by scraping with an Exacto knife, repaint some foreground items and then paint in the water, sky and such.

Rick commented that when he began his venture into Reverse Glass Painting, "I didn't know that yellow and blue paint made green ... anyone can do this." Thank you Rick for your compelling, superb presentation and instruction on Reverse Glass Painting.

Time as Franklin Perceived Time Roger


Kellogg explained that near 1758, Benjamin Franklin invented a truly unique clock that until recently was unknown to most Americans. Franklin's original four-hour dial plate required the use of a single rotating hand, unlike conventional European dial plates using a minute and an hour hand. This model of American ingenuity is now revealed in a manner of which Benjamin Franklin would be proud.

A modernized Franklin Timepiece is handcrafted and hand finished by American craftsmen using solid kiln-dried cherry. A specially engineered four-hour revolution precision quartz movement drives the clock's single hand. The dial-plate, a reproduction of the 1758 drawings, is printed on natural parchment, and protected with beveled glass for a distinctive look.

The folks at Founders Keepers hope the Franklin Timepiece will provide a unique and original furnishing accessory to the home or office of those who appreciate American history and ingenuity.

For demonstration clarity, Roger substituted Arabic numerals for the original Roman numerals.

To tell time using the Franklin Timepiece, the dial plate is divided into four quarters; each quarter contains sixty minutes. The hours, in sets of three, are shown at the beginning of each quar-



ter. The hours in each set differ by four. The clock's single hand takes four hours to make a revolution and counts the minutes of the hour it has just passed. The time, as it appears in the picture (based on the position of Roger's thumb) is either 42 minutes past twelve, four or eight o'clock. There is a four hour ambiguity and folks complained to Benjamin Franklin about this situation. To this complaint, he replied "If you don't know the hour to the nearest four hours, you don't need a clock, you need a calendar."

Seaubin Swiss. clock's The figurines are two monks. One is reading the bible and the other is ringing the hours.

William Gilbert Shelf Clock

William Gilbert Shelf Clock - All original painted-glass and dial. The label reads "Patented case by George B. Owen, September 28, 1869." An interesting fact about this clock is the logo above the cannon arbor on the dial which has a "G" in the middle, a "C' on one side and "Co" on the

other, which stands for Gilbert Clock Company.

Donna's Pet Oswald Donna Kalinkiewcz begins

with "I have a new pet." as she introduces her J. Oswald Company clock. This very cute doggie clock was found on the ShopGoodwill website in as-good-as-new condition. Some miner movement cleaning and a coat of clear wood lacquer was all that was necessary to bring him back to life, according to

These clocks were patented in the 1920's, manufactured



until 1950, and today sell for \$200 - \$800. This Scotty Dog and the Owl were the most popular, leaving the Lions, Monkeys, Cats and Skulls behind in sales.

Today, most all of the J.

Oswald Company records have been destroyed, leaving us with little knowledge about company.



Time is told on this clock by gazing into its cock eyes. The right eye points to the hour and the left to the minute. Cute! ■

Military Timepieces on Display

Kent Singer and the other Watch People displayed an impressive variety of mostly World War II Timepieces. Other timepieces included Vietnam era watches. Included with the watches and time keeping/recording devices was descriptive

literature and information from WWII ads contained in the Jewelers Circular.

A "use" discovery by Ed Ueberall and Kent Singer was a watch used to imprint a Time Stamp on air reconnaissance photos. Another watch person explained that a prism was mounted to the





front of the timepiece to reflect the time onto the photograph.
