Atlanta School of Horology's First

Class by Tom Noesges

The Class - The Atlanta School of Horology, Inc. (ASH) will be conducting its first class on August 21 and August 28, 2010. The class, AC101 Eight Day American Kitchen Clock, will consist of 16 hours of instruction taught by our own Bill Knaak.



Bill will teach the repair of an eight-day, time and strike, pendulum clock with open mainsprings. Students will learn and gain confidence in repair procedures and techniques, such as movement and mainspring cleaning using both hand and machine methods, lantern pinion and wheel repair, pivot and arbor repair, pivot polishing and pivot hole bushing using both hand and machine methods, escapement theory, and time train and strike train troubleshooting.

Currently, we have the following students enrolled in this class:

ASH has plans to develop curricula for a myriad of horology related classes for the balance of 2010. Future classes will include

advanced clock repair, watch repair, case restoration and in-depth lectures on history and operational theory. We are very excited to bring these classes to Atlanta Chapter 24.

Polishing Brass - by Tom Noesges

Henry Newman gave the membership a fascinating history of

his personal experiences with keeping brass alive and bringing it back to life. Henry began sharing the times he spent polishing the brass on his father's 1904 Oldsmobile. In 1904, chrome plating didn't exist - all of the exposed metal was brass and required hand polishing. Today, Henry uses Wenol Metal Polish and has used this product for 15 years. Wenol can be purchased for \$39 at most auto parts stores and

Amazon.com. After the polishing is done, Henry finishes the job with a coating of either carnauba wax or a nitro-cellulose lacquer mixed 2-to-1 with lacquer thinner. Between the initial cleaning and the final bright finish, the pieces are buffed-out on a high speed electric buffer and hand rubbed with 0000 steel wool. ■

The Cuckoo Clock - The other night I was invited out for a night with the guys. I told my wife that I would be home by midnight... "promise!"




Well, the hours passed quickly and the beer was going down way too easy. At 3am, drunk as a skunk, I headed for home.

Tips, Hints, Products & Processes

A Better Mainspring Clamp - Pete Schreiner commented that on open mainspring American clocks one of the common tools used was the mainspring (MS) "C" clamp to unload the spring for safe removal. Often posts and other clock parts make inserting the MS clamp





difficult if not impossible. Using an automotive hose clamp makes the job easy because, after fully winding the clock's MS, you have only to insert the thin band of hose clamp steel around the MS and the clock's post, tighten the hose clamp and then let the MS down into the hose clamp. You can then remove the MS from the hose clamp using a spring winder and keep the hose clamp in the configuration you used to remove the MS. Doing so allows for an easy reinstallation of the MS into the clock. The auto

hose clamp turns out to be the universal Mainspring Clamp.

A New Movement Test Stand - George Waterhouse showed a movement holder vise being sold by Gene Volk in NC for \$20. Bass Pro Shop sells a similar device but calls it a Fly Tying Vise. According to George, you simply attach the "Test Stand" to the edge of a table. The stand will hold any size spring clock. George has held a 30-hour cuckoo clock with this stand. Bernie Tekippe suggested that two stands could be used to hold a weight driven clock. George suggested using a pillow underneath



if you use the fly tie holder to hold a weight driven clock.

Case Restoration and The Family OG-Show & Tell by Tom Noesges

Case Restoration Randy Grunwell showed us a round top ordinary looking case. However, when he got it, it had no top nor veneer and had been through a fire. This clock was Randy's first purchase. Tom Fowler and Randy bought this clock together. Larmar Meadows helped put the veneer on it. The clock is said to have invoked the skills of many of the



Atlanta Chapter members. The clock has a Seth Thomas movement installed.

The Family OG - Randy then showed the members an OG clock that contained a note that stated "Shelf clock inherited by



Grandma Oveit. She used this in her school room in Richfield, OH in the 1860's. It is called a GG clock which pertains to the panel around the face." This was Randy's Great-Great-Great Grandmother. Something else written originating from It's About Time Shop, Inc. states "...its an 1840 Atkins and Porter—label printed by Elihu Hartford with a replacement value of \$200. OG 30 Hour figured maple." Anyone knowing anything about this clock, contact Randy Grunwell. ■





FROM THE SOUTH (IN TOWN): Take I-285 to Exit 39B which is Highway 78, continue on 78 to Exit 7 onto Hugh Howell Road. After this exit, immediately turn right onto Lilburn-Stone Mountain Road. After 0.2 mile, turn right onto Old Stone Mountain Road. Continue to the intersection of Rockbridge and Five Forks Trickum. Turn left on Rockbridge Rd. The Aquatic Center is two blocks north on left.

The Atlanta Chapter of the NAWCC typically meets the first Sunday of February, April, June, August, October and December. As part of the Mid-South Group, it also sponsors the regional meeting in Chattanooga on Labor Day Weekend each year, in rotation with the Alabama and Tennessee chapters.

FROM THE NORTH-WEST: Take the I-85 east exit from I-285. Exit 99 and turn right on Jimmy Carter (Hwy 140). Continue and bear left onto Rockbridge Rd. Aquatic Center will be on right—two blocks before Five Forks Trickum Rd.

FROM CUMMING / HALL COUNTY: Take Exit 101 Indian Trail / Lilburn Rd NW off southbound I-85. As you cross Hwy 29 Lawrence-ville Rd, Indian Trail becomes Killian Hill Rd. Turn right onto Five Forks Trickum Rd.

Turn right onto Rockbridge Rd. Aquatic Center is two blocks north on left.
