




SHOW AND TELL

Frank Lindhauer showed a watch stand in the shape of a goose with a double hook held by the end of the beak. The device is estimated to be from the late 19th or early 20th century.



Warren Brook showed a William E Hadlock wall regulator dating from approximately 1880. The case is solid mahogany, the tablet emblem is gold leaf, and the pandulum has a gilded wood stick. The movement is made with heavy bra



Pete Schreiner showed several images of a William E Hadlock clock that is currently being restored by new member Dana Merrill. This picture shows the thick brass plates of the movement.






George talked about an Ansonia clock on which he recently performed a case restoration. After a thorough cleaning, he replaced the crown and ornaments with resin reproductions which were painted with a burnt umber and finished with a gel top coat. The gold pieces were repainted as well.

RESTORATION OF THE STATE OF GEORGIA CLOCKS

Pete showed a PowerPoint presentation on some of the work that he and George Waterhouse have performed on vintage State clocks. From the Chief Vann House in Dalton is a Mark Leavenworth pillar and scroll clock with a wood movement. The clock was cleaned







Also from the Chief Vann House is a John Cuthbert Tall Clock from the 1790s. Pete crafted a new winding key and repaired this broken wheel tooth and multiple, severely worn pinions, whose wear was caused by the use of oil on the wheel teeth. George made multiple case repairs to the door; those repairs were essentially imperceptible when completed.



Lastly, Pete showed several slides of a French Crystal clock from the Governor's Mansion that is powered by a Swiss Angelus battery in a ETA 2421 N movement dating from the mid 1950s. Pete restored multiple parts of the movement and installed a new balance.

FEBRUARY PROGRAM: AN OVERVIEW OF ESCAPEMENTS, BY BERNIE TEKIPPE

The purpose of the escapement is to transfer enough energy to the pendulum to keep it swinging. The earliest escapement was a crown wheel, invented about 1500. In this design, the pallets had to move about 20 degrees and required a short, light pendulum moving in a slow wide swing which was subject to variability in amplitude. This caused high circular error and poor time keeping.





The next major development was the recoil or anchor escapement by Huygens in 1675, which had a much narrower swing, as little as two degrees, thereby reducing circular error. The escapement sends energy to the pendulum to help propel the pendulum, but that impulse varies and therefore the pendulum swing varies. This is the escapement error and is caused by the friction on the escapement.

The deadbeat escapement was invented about 1700 and differed by having two active surfaces per pallet. The curved edges of the pallet surfaces are always equidistant from the verge pivot point, and friction is reduced. Its design allowed the impulse to be fixed and reduced escapement error.



The escapement designed by Bernie attempts to reduce timekeeping error. As shown here, the pallets are mounted on the pendulum itself, so that the escape wheel pushes the pallet and pendulum directly and thus reducing error related to multiple friction points. The escapement itself add some recoil due to an adjustment in the rounded pallet. In sum, the escapement error increases the speed of the pendulum by the same amount as the circular error slows it down, therefore cancelling the effect of each other.


