APRIL PROGRAM HIGHLIGHTS

The Astronomical Basis for Time Keeping:

How does astronomy determine how we measure time—by Jim Guinn

Our time keeping is based on two primary astronomical motions and one secondary. The primary motions are the Earth's rotation around its axis which defines the day, and the Earth's

revolution around the sun which defines the year. The secondary motion is the Moon's revolution around the Earth which loosely defines the month.

Because the Earth's axis is "tilted", and its orbit around the Sun is not a perfect circle, there are slight variations to the length of the solar day, i.e. the time for the Sun to move across the sky. This has caused scientists to define a day based on the average motion of the Sun, rather than using local solar time from a sundial. The rotation of the Earth is also slowing down due to the friction of the moving ocean tides. To be as consistent as possible, scientists now define seconds in terms of light emitted by a particular type of atom, rather than using an astronomical definition. The length of the year, however, is not always so consistent. Extra seconds, called leap seconds,



have to be added to the end of years periodically. The last one was just added at the end of 2016!

THIS MONTH'S PUZZLER

The Adventures of Sherclock Holmes – The Tower of Hanoi

One evening, Mr. Sherclock Holmes found his friend, Dr. John Watchson, in their living room occupied with an interesting toy consisting of a frame with three vertical pegs, and a number of different sized disks, with a central hole in each, that could be moved from peg to peg. (Please see the simplified version below.)



"Developing an interest in Asian architecture, I see, Watchson," said Sherclock. "What are you talking about, Sherclock?" said Watchson. "That is an example of the classic puzzle called the Tower of Hanoi, and a beautiful example, I must say. The carved pieces are quite extraordinary. I must be paying you too much," said Sherclock, "if you can afford that set." "Quite frankly, you don't pay me anything," said Watchson, "and this was a gift from my friend, Prof. Nguyen, when she returned from overseas. She told me that I should start with all the disks on the same peg, larger ones at the bottom, up to smallest at the top. I have to move all the disks onto another peg, moving one disk at a time, and never putting a larger disk on top of a smaller disk. She told me she would buy me a very nice dinner if I could do it. There are sixty-four disks, so moving one disk every second, I think I ought to be able to do it in about sixty-four seconds. What do you think?" "I think it's a wonderful idea. Take it into the other room and don't bother me until you've finished. And then you can start putting rice grains onto a chess board," said Sherclock. "What?!?" said Watchson.

How long will it take Dr. Watchson to complete his puzzle (moving one disk per second), is Prof. Nguyen in any danger of paying for dinner, and what does this have to do with rice and a chess board? 

Next Meeting of Chapter 24



FROM THE NORTHWEST: Take the I-85 east exit from I-285. Exit 99 and turn right on Jimmy Carter (Hwy 140). Continue and bear left onto Rockbridge Rd. Aquatic Center will be on right—two blocks before Five Forks Trickum Rd.

FROM CUMMING / HALL COUNTY: Take Exit 101 Indian Trail / Lilburn Rd NW off southbound I-85. As you cross Hwy 29 Lawrenceville Rd, Indian Trail becomes Killian Hill Rd. Turn right onto Five Forks Trickum Rd. Turn right onto Rockbridge Rd. Aquatic Center is two blocks north on left.

FROM THE SOUTH (IN TOWN): Take I-285 to Exit 39B which is Highway 78, continue on 78 to Exit 7 onto Hugh Howell Road. After this exit, immediately turn right onto Lilburn-Stone Mountain Road. After 0.2 mile, turn right onto Old Stone Mountain Road. Continue to the intersection of Rockbridge and Five Forks Trickum. Turn left on Rockbridge Rd. The Aquatic Center is two blocks north on left.
