

Minutes of NAWCC Atlanta Meeting on Feb. 4, 2018

Brooks Coleman started us off with a brief auction and then presided over the business meeting.

Randy Grunwell announced progress on the process of creating a clock badge for the Boy Scouts.




George Waterhouse and Chris Brown have made several trips to the Governor's Mansion to maintain the state clocks. George has also talked with Chris Gegen (coordinator of media and technology at the Gwinnett School of Mathematics, Science, and Technology) in order to create a series of videos on the Mansion clocks.

There was a detailed discussion of the J. W. Self estate clocks. The family will be donating two clocks. One clock will be placed at the Governor's Mansion, and the second clock may be placed at either the Capitol or the Atlanta History Center. Further discussion with these facilities will be needed to finalize the proposals. The chapter has already voted to spend up to \$1000 to purchase another clock as well; the status of the third clock (both ownership and placement) needs to be clarified by

the chapter. (Since the February meeting, a review of the minutes from the August, 2017 Chapter 24 meeting [thanks to Gary Walton] shows that the motion which passed indicates that the clock or clocks purchased by Chapter 24 will be owned by Chapter 24 and may be loaned to be put on view. No discussion of making this clock or clocks a gift was made.) An auction of the entire J. W. Self Estate will be held by Auction 78 on May 4th and 5th; the clock collection will be sold on May 5th. A special chapter newsletter will be sent

to the membership with more details.

In other business, the chapter voted to approve the purchase of two new coffee makers for use at the Sunday morning meetings. The April meeting will be moved to the second Sunday (April 8th) in order to avoid conflict with the Easter holiday on the first Sunday. The June meeting will be held on a date to be determined, since Mrs. Sandra Deal has invited the chapter to the Mansion for a tour. However, the tour will take place during the week, probably Tuesday June 5th or Thursday June 7 about lunchtime. The national NAWCC organization is asking for a donation to the 2018 National Convention in



York, PA. The chapter approved a \$200 contribution. Brooks mentioned several of our chapter members who have experienced serious recent illnesses.

When is the best time of the day? Answer: It's 6:30, hands down.

Why don't people eat clocks? Answer: It's too time consuming.

LAST MONTH'S PUZZLER

Solution: This is a little different kind of puzzle because <u>every</u> hand position is the mirror image of another hand position. The mirror image of any hand position is exactly 12:00:00 minus the time of the original hand position. For example, 2 hours, 17 minutes, and 23 seconds is exactly the mirror image of 9 hours, 42 minutes, and 37 seconds. Perhaps the reason Sherclock thinks this is a slightly interesting puzzle is that the mirror image of a clock moving forward is exactly the same as a clock going backwards in time, and that some objects, like a spinning top, look exactly the same if you look at them in the mirror <u>and</u> going backwards in time!

Looking up from his evening paper, Sherclock Holmes, Consulting Time Detective, noticed his friend, Dr. John Watchson looking from hand to hand. "What is it now, Watchson? Today, however, at noon, one of them had lost exactly three minutes and the other had gained exactly four minutes." "That is a problem," said Sherclock, "which is yours and not mine." "Yes, thank you," said Watchson. "But I was wondering if the two watches will ever read the same time as each other ever again, and will they ever read the correct time together ever again." "Of course they will," said Sherclock, "if you go set them both again, right now!" "No," said Watchson, "I meant if they keep going exactly as they are now." "Well, all I can say is that I hope you're patient," said Sherclock and returned to his paper.

FROM THE NORTHWEST: Take the I-85 east exit from I-285. Exit 99 and turn right on Jimmy Carter (Hwy 140). Continue and bear left onto Rockbridge Rd. Aquatic Center will be on right—two blocks before Five Forks Trickum Rd.

FROM CUMMING / HALL COUNTY: Take Exit 101 Indian Trail / Lilburn Rd NW off southbound I-85. As you cross Hwy 29 Lawrenceville Rd, Indian Trail becomes Killian Hill Rd. Turn right onto Five Forks Trickum Rd. Turn right onto Rockbridge Rd. Aquatic Center is two blocks north on left.

FROM THE SOUTH (IN TOWN): Take I-285 to Exit 39B which is Highway 78, continue on 78 to Exit 7 onto Hugh Howell Road. After this exit, immediately turn right onto Lilburn-Stone Mountain Road. After 0.2 mile, turn right onto Old Stone Mountain Road. Continue to the intersection of Rockbridge and Five Forks Trickum. Turn left on Rockbridge Rd. The Aquatic Center is two blocks north on left.
