#### New Business:

Charles presented the Treasurer's Report which can be found on page 4.

Bob Geier provided a brief update on the progress of preparations for the 2022 Labor Day Weekend Mid South Regional. The annual MSR Planning Meeting will be held at the Dalton Center sometime in April instead of the usual meeting location (Wally's in East Ridge). A notice will be circulated in advance.

Chris Martin, Exhibit Chair for the 2022 Regional described progress on enlisting participants for the exhibit. The exhibit will display examples of horological creations of our membership. Byron Tekippe has agreed to display an example of Bernie's regulator.

Donna Kalinkiewicz noted that Hershede parts are now available from the Griffin Clock Parts Company. Griffin acquired R&M Imports including the remaining inventory of Hershede and the former LaRose company. Christine Griffin has authored a new book on Hershede which she will roll-out at the National this year in Dayton.

# Program

Chris Brown presented a program entitled "Practical Clockmaker Applications of a Bench Lathe". Using his National Peerless lathe, Chris discussed typical as-found pivot wear conditions and demonstrated his techniques for restoring and polishing. He also detailed techniques to make, use and clean burnishing tools.


Chris explained operation of his lathe and purpose and functions of the cross slide, steady rest and various chucks. Additionally, Chris discussed how to drill and replace pivots. Once this is done, the final steps of sizing and installing bushings on the plates was described.

Dan Jefferies presented a Southern Label Ogee clock marketed by John Jackson from Athens GA. The Jackson label listed the origin as Baker County GA. It is pasted over a pink colored Seth Thomas Connecticut label. Dan mentioned that John Self would have appreciated this example. Dan discussed the history of Baker County and specifically the 1994 Flint River flood which washed away much of the Newton GA town square with the exception of the courthouse.



Les Dobbins presented two handy clock repair accessories that were previously discussed with the Tuesday night group. These included a magnetic wrist band for freeing-up hands and securing small steel components during repairs and gloves with a small integral finger flashlight. These items are available through Amazon.

Graham Cross presented a fourteen inch walnut Ansonia Gallery clock with an unusually well preserved original dial. A note behind the dial detailed that the clock was cleaned by a Mr. Wolf in Buffalo New York in 1921.
