## Program

Chapter 24 VP Jeff Whitfield introduced Tim Orr and his program titled "Longitude for Beginners". Tim is a 30 year NAWCC Silver Star Fellow previously active in the Nashville chapter now living in Colorado. Tim is now a member of Chapter 160 in Boulder.

Tim discussed the story of English Commodore George Anson and his six ships mission in 1740 to plunder Spanish treasure. The uncertainty of Navigation at Sea and factors including Ignorance, Misfortune and Coincidence would play roles in this story. Delays in the recognize, accept and drive to develop the chronometer as the solution to the 1714 Longitude Act, Parliament's Longitude Prize, would impact Anson and the lives of many others.

With the War of Jenkin's Ear (1739-1748) in progress, Commodore Anson would arrive at the eastern entrance to the Straits of Magellan, Punta Dungeness, early in the winter of 1740. Since both Chile and Argentina were Spanish territories, he could not put to shores for supplies and fresh water here. Through six weeks of inclement weather in the Straits, two of his six ships had to return home and another was lost. When the weather cleared, Anson discovered that he had circled back to Point Dungeness. The uncertainty of calculating longitude with a compass (local magnetic variations from north) and estimating speed by dropping a float, counting knots and timing with a sand hourglass resulted in error. He was now low on supplies and 626 of his original 961 complement were lost due to an epidemic of scurvy. He knew that if he put ashore for fresh food and water, the crew would recover rapidly, but could not. It was not yet understood that scurvy is a vitamin C deficiency.

Latitude calculation was relatively certain by using a sextant to measure angles from the North Star Polaris or Sigma Octantus, the star near south pole to the horizon. To navigate to a destination, one would sail to the correct latitude and then sail either east or west, at times on a hunch.

Anson's destination was Juan Fernandez, about 1500 miles north at 33 degrees south latitude and 300 miles west of Santiago, Chile. Anson proceeded North and then guessed correctly by turning west but did not sail far enough. He would turn around only to retrace steps west after a week and loss of another 70. He would go on to seize millions in gold doubloons following respite at Juan Fernandez.

The Basics: Since the earth rotates once in 24 hours (15 degrees per hour), each degree takes 4 minutes. The British selected the Observatory at Greenwich (London) as the Prime Meridian. Therefore, if one knows both the local time and time at the prime median, the difference in minutes is proportional to the number of degrees east or west of Greenwich. Local time was calculated with a sextant from the sun's elevation.

John Harrison's incredibly precise clocks would prove resistant to ships motion and wear. Examples of H1, H2 and H3 didn't even require lubrication and run today after 300 years. In 1835, H4 performed within 20 seconds in a month.

Coincidently, in 1715, HMS Centurion, which would become Anson's flagship in 1740, carried Harrison's H1 chronometer to Lisbon. During that voyage, H1 outperformed the ship's navigator and thereby provided proof of concept. In the years to follow, Harrison was required to disassemble his prototypes and disclose secrets to satisfy reviewers and other clock makers of its suitability for duplication at a time before there was mass production of any sort. Harrison's prototype chronometers would be miniaturized and then produced by the thousands. At the age of 80, Harrison would be awarded Parliament's Prize in 1773.

## Program Continued:

The story of Anson is told in Patrick O'Brian's 1956 novel <u>The Golden Ocean</u>. Years later, the "Master and Commander" series would be based on Anson and this novel. Many thanks to Tim for this very interesting and inciteful Program.
