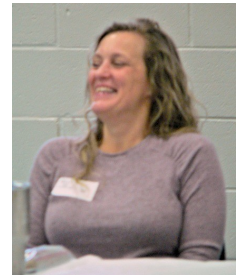

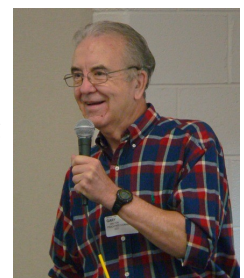
Chris Brown called for a round of applause in thanks for outgoing President Mary Jones for her service to the Chapter to which all heartily responded.
